PARAMETERS FOR ITS LONG TERM INVESTMENT ACCOUNTS TO ALLOW A MAXIMUM OF 10% TO BE HELD IN CASH EQUIVALENTS AS RESERVES FOR PURCHASES, BETWEEN 30% AND 50% IN FIXED INCOME AND BETWEEN 50% AND 70% IN EQUITIES WITH A 10% DIVERGENCE ALLOWANCE.
